Dear Attorney General Holder and Secretary Clinton:

I understand that on April 9, 2012, the United States Department of Justice filed a motion in the United States District Court for the District of Columbia to amend an August 23, 2011 restraining order against Ponsford Overseas Ltd. and Tula Finance Ltd in Miscellaneous Action No. 11-452 (CKK). The Department of Justice represented to the Court that it was moving "[p]ursuant to a third mutual legal assistance request from Curaçao." Id. at 3. I understand that the request, and previous requests, came from the Public Prosecutor in Curaçao.

The competent authority in Curacao to issue a mutual legal assistance request from Curaçao under the Treaty Between the United States of America and the Kingdom of the Netherlands on Mutual Assistance in Criminal Matters, or under the separate Agreement Between the Government of the Kingdom of the Netherlands and the Government of the United States of America Regarding Mutual Cooperation in the Tracing, Freezing, Seizure and Forfeiture of Proceeds and Instrumentalities of Crime and the Sharing of Forfeiture Assets is the Minister of Justice of Curaçao or his designee.

The position of the Ministry of Justice of Curação is that the April 4, 2012 ruling by the Court of First Instance of Curação, ordering that the seizure of those assets be lifted, is followed.

By this letter, I am formally requesting that the Department of Justice withdraw its motion to amend the restraining order against Ponsford Overseas Ltd. and Tula Finance Ltd. I further request that the Department of Justice instruct the District Court that it is the position of the Curaçao government that the April 4, 2012 order of the Court of First Instance of Curaçao be honored and that the seizure be lifted. Furthermore, no further seizure may be put in place concerning these companies' assets in the United States. without prior written authorization of the Minister of Justice.
